I am writing concerning my case, 2023CF00562CFAWS and respectfully request your consideration on a matter that I believe is crucial for supporting my defense. I am a honorable discharged veteran that served in the military for two decades supporting and defending the United States freedom and liberty.

I have had several discussions with my attorney related to filing a Brady Material Motion about all 911 calls evidence. My attorney has not provided a date as when the Brady Material Motion will be filed.

The Demand For Discovery is dated February 16, 2023 and Answer to Demand for Discovery is dated May 8, 2023. Pasco County Sheriff only retains 911 calls for 90 days. I do not know if all 911 calls evidence is available.

The Motion to Dismiss Based Upon Statutory Immunity Hearing was held on October 13, 2023. The State Prosecutor provided my Attorney one half of the Body Worn Camera footage on or about October 6, 2023. The State Prosecutor provided my Attorney the second half of the Body Worn Camera footage on or about November 8, 2023. The State Prosecutor withheld evidence, I could not prepare nor provide a defense during the Motion to Dismiss Based Upon Statutory Immunity Hearing.

Considering the past circumstances with regard to evidence for my defense. I am asking this Honorable Court to conduct a Brady Material Hearing.

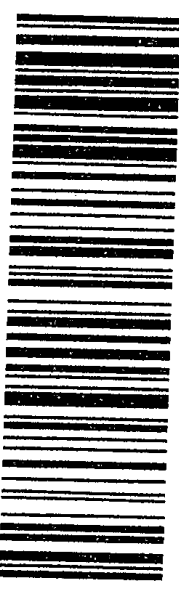

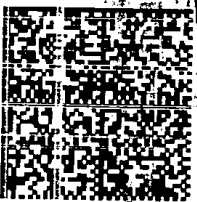
