On the above date and time, I investigated an Aggravated Assault. The victim, Michael Krnajaich, stated he was arguing with the defendant, William Clifton, regarding temporary speed bumps in the roadway to slow traffic down while kids were playing in the area. During the argument the defendant was told not to touch the victim's belongings but did so anyway. Michael then pushed William one time. William then steadied himself, stepped to the side, drew his firearm, and pointed it directly at Michael. Michael in fear of being shot ran for cover. William proceeded to point his firearm directly at three other victims (Daniel Zweifel, Sara Connolly, and William Adams) who were not involved in the altercation. This act placed all three


